1. The candidates are required to apply through the ONLINE process (through the link <https://career.sihmbalangir.org>). The online application should be supported by uploading the scanned copies of all **ORIGINAL** educational and experience certificates or else the application will not be considered.
2. The qualifications and other conditions prescribed in the present advertisement are subject to the regulations/norms stipulated by NCHMCT from time to time.
3. The eligibility and qualifications prescribed shall be reckoned as on the closing date of online application for each phase. It shall be the responsibility of the candidate to ascertain his/her own eligibility for the post in accordance with the prescribed qualifications, experience, etc before submitting application.
4. Candidates are advised to fill their correct and active e-mail address in the online application as all correspondence will be made by the Institute through that e-mail address only. Test/Interview schedule will be published on the website and e-mailed to the candidates in their registered e-mail address in due course. No separate letter (Hard copy) will be sent for this purpose. Further, for any updates, subsequent amendments in the advertisement or publication of results, please visit the Institute website regularly. No correspondence whatsoever will be entertained from the candidates regarding conduct of exams, result of interview, reasons for not being called for interview or selection etc.
5. In online application form, correctness of information is the responsibility of the applicants. All the details furnished in the online application will be treated as final and no changes shall be entertained. Application once submitted, cannot be altered or resubmitted under any circumstances. Further, no request with respect to making changes in any data/particulars entered by the candidate in the Online Application will be entertained, once the application is submitted successfully.
6. Suppression of factual information, submission of fake documents, providing false or misleading information or canvassing in any manner on the part of the candidates shall lead to disqualification. Any time even after appointment if it is noticed that the candidate does not possess the eligibility prescribed in the Notification or that the claim made by him/her with respect to the qualifications/experience/other credentials are false or misrepresented, then his/her appointment shall be terminated forthwith. The candidate shall be held solely responsible for the same and the consequences thereupon.

8. Applications will be summarily rejected if hard copy of the same is not received with all the supporting documents on or before the last date of receipt of application.
9. All the information/addendum/corrigendum etc subsequent to this Advertisement, if any, will be uploaded in the website only. Candidates are advised to regularly visit the institute website **www.sihmbalangir.org**, for updates. The SIHM will not be responsible for any information which is unnoticed by the candidates. The SIHM will issue call letters to the shortlisted candidates and other correspondences through email only. Reply to the queries raised by the candidates will be provided considering the merit of the query.
10. Candidates must upload valid SC/ST/OBC (Non-creamy layer Certificate)/PwBD (as applicable) issued by the Competent Authority and forward copy of the Certificate along with Hard Copy of the application.
11. Applicants are advised to submit the applications well in advance without waiting for the last date to avoid postal delay or delay due to technical or other unforeseen events or circumstances. The SIHM will not be responsible for any delay in submission of application at any stage.
12. Candidates already in service must submit Endorsement by the Employer in the prescribed format. Candidates who are unable to upload NOC/ Endorsement by the Employer may upload an undertaking stating that the NOC/Endorsement by the Employer will be submitted along with hard copy of the application or at the time of interview, if called for. Candidates failing to produce NOC will not be permitted to attend the interview.
13. Candidates possessing Foreign Degrees should submit Equivalence Certificate issued by the Association of Indian Universities (AIU) at the time of interview, if called for.
14. Candidates, who have obtained degrees or diplomas or certificates for various courses from any institution declared fake/derecognized by the University Grants Commission at the time of obtaining the degree, shall not be eligible for being considered for recruitment to the post advertised.
15. Selection will be made based on the candidates' performance in the interview, written test, skill test, and teaching skill demonstration, as applicable. The selection process may vary depending on the post, and not all stages may apply to every post.
16. The appointed candidates shall be eligible for allowances as admissible under SIHM (Society) rules and orders in force from time to time. The candidate shall also be covered under the National Pension Scheme (NPS).

17. No interim queries regarding interview/selection will be entertained.
18. Canvassing in any manner whatsoever shall be deemed to be a disqualification and the candidature of such applicant is liable to be rejected.
19. In case of any disputes, with regard to the recruitment process shall be subject to the court having jurisdiction at Balangir Only.
